Sub: Group Accident Insurance Scheme - 2021-22

The existing Group Accident Insurance Scheme for the staff is due to expire on 31.03.2021. It has been decided to renew the scheme for the financial year 2021-22 which will be operative from 01.04.2021. The scheme is extended to all staff members (Regular/GBCS/Contract) including their dependents (as per iHRMS medical dependency list) and also to retired staff and their spouse subject to the conditions specified. The scheme is operated through a policy with M/s The Oriental Insurance Company Limited.
